



Once the note is approved, it will move to the archive. If you click on Archive and then Search, you will see the note there and it can be printed with a signature (be sure if you are looking for an older note to choose Transcribed within for the correct amount of time)



To Print, check box the note you want and click print. (If you just approved, you may see a yellow lock beside the name. That means that it is still in approval process and need to wait a few more minutes to print before signature will appear. Just click search again after a minute or so and it should be ready)
